These signs are invaluable to firefighters, EMT's, and police officers, who may be looking for your home in your time of need. Similar signs have been installed in other communities with startling results.

The Salem-Morrow Fire Department is selling these signs at the low cost of \$12.00 each. If you wish to have the SMFD mount your sign for you, they will do so for \$14.00. Each sign has your street address prominently displayed on both sides in highly reflective 3" numbers against a green background similar to those on an interstate sign. The signs are installed in such a way that assures their visibility, even in high grass and snowy weather conditions.

Rumpke Now Accepts More Material in Recycling Program

Morrow residents can now recycle carton containers like juice, milk, soy milk, soup, broth, egg substitute and wine cartons, curbside. Rumpke recently announced that cartons are now accepted in its residential and commercial recycling programs.

“As Ohio’s recycling leader, Rumpke continues to invest heavily in our recycling programs to ensure residents can recycle the most amount of material possible,” said Jeff Rumpke, vice president. “As Rumpke continues to enhance our recycling program, manufacturers are complementing our efforts with new ways to recycle more materials.”

To ensure your cartons are recycled, please follow these easy steps:

1. Empty the container. Containers still containing liquid will not be recycled
2. Remove caps or straws
3. Toss the carton in the recycling container with other acceptable items

In addition to cartons, residents can recycle:

- Plastic bottles and jugs (please flatten and reattach the lid)
- Glass bottles and jars (any color)
- Aluminum and steel cans
- Empty aerosol cans (with lids and tips removed)
- Paperboard (cereal boxes, 12-pack containers, etc.)
- Cardboard (broken down to 3'-by-3' sections)
- A variety of paper products, including:
 - Office paper
 - Newspaper
 - Magazines
 - Junk mail and envelopes (with or without windows)
 - Telephone books
 - Paper grocery bags

Highlawn Avenue Reconstruction Project & Welch Road Rehabilitation Project, Phase I

Two roadway and infrastructure improvements projects in the Village of Morrow, which began in August are presently on hold due to the Winter weather. The Highlawn Avenue Reconstruction Project is funded by the Village of Morrow’s 2012 Community Development Block Grant (CDBG) award. The Welch Road Rehabilitation Project, Phase I is funded, in part, through our 2013 CDBG award. Warren County Grants Administration is administering both projects on our behalf, due to the CDBG funds. The Warren County Commissioners awarded the contract to Brunk Excavating, Inc. from Monroe, Ohio, who was the low bidder on both projects, at their August 13, 2013. These projects are both being managed by Warren County Grants Administration. These projects will soon be wrapping up for the winter and will begin again in the spring with some final touch ups and repaving. Thank you for your patience!

March Lunch & Learn – A Musical Center? Ohio Shakers at the Heart of it All – March 19, 2014

Topic: The spread of Shakerism to the "West" brought about dramatic changes in how the Shakers produced music. In Ohio, Shaker leaders and new converts alike stood at the forefront of music production for the whole Shaker world. This presentation looks at two Shaker musical giants - Issachar Bates and Richard McNemar, who in 1832 launched a major musical project from the Shaker village of Watervliet, Ohio, on the outskirts of Dayton.

Speaker: Carol Medlicott is Associate Professor in the Department of History and Geography at Northern Kentucky University. She is author of *Issachar Bates: A Shaker's Journey* and *Partake a Little Morsel: Popular Shaker Hymns of the 19th Century*, co-author of *Richard McNemar, Music, and the Western Shaker Communities*, and has written numerous articles and book chapters on Shaker history.

April Lunch & Learn - Dayton, Ohio's Forgotten Industry: The Story of the City's Role as the 'Toy Center of the United States' – April 16, 2014

Topic: Many people are aware of that Dayton, Ohio is the birthplace of aviation, the cash register, the automobile self-starter and the pop top can. There was also a time, however, when Dayton was the home to a major toy industry. Tell me more: The Warren County Historical Society offers four hands on, interactive school tour programs which address the revised State of Ohio Academic Content Standards for 4th through 8th grade students. The programs are:

2. Exploring Pioneers Technology – Ohio Academic Content Statements 3, 8 & 23
3. Warren County and the Underground Railroad – Ohio Academic Content Statements 5, 7 & 14

May Lunch & Learn – It Cures Like Magic: The Fads and Frauds of the Golden Age of Patent Medicine Quackery – May 21, 2014

Topic: 19th century America witnessed a boom in the "patent medicine" industry. Patent medicines were NOT medicines that had been "patented" but rather "secret formulas" and unproven remedies that were sold directly to the public as medical cures. Some patent medicines did very little harm; others actually delivered their promised results, albeit often with very dangerous ingredients; and still others were what amounts to poisons. Dennis will display and discuss the supposed curative properties of some his personal collection of patent medicine potions, and bottles, many of which were actually from Warren County.

Speaker: Dennis E. Dalton is the author of the book Waynesville and Wayne Township, as well as a history researcher, lecturer and storyteller. He is a native of Waynesville, Ohio where his maternal roots go back to the family of Daniel Boone.

WCCC Welcomes Board Members for 2014

Three new board members and one returning member were sworn in at the Warren County Career Center organizational board meeting Jan. 14, joining with three returning board members. Two of the new members have served on the WCCC board in previous years. WCCC EMT Programs Earn Re-Accreditation

Warren County Career Center received final approval and a Certificate of Accreditation from the State of Ohio Board of Emergency Medical Services to continue to deliver EMS training classes through June 30, 2016. This three-year reaccreditation means that WCCC is able to offer First Responder, EMT Basic and EMT Advanced classes, which are all available to adult students. High school students in the WCCC Fire Science program study EMT Basic under the Adult Technical Center charter.

The program has specific articulation agreements with Cincinnati State Community and Technical College and Sinclair Community College. Also, through College Prep 2, students earning certification can use their certificate at any college in Ohio toward a degree in EMT Paramedic.

The accreditation process begins with filling out an application packet, which asks for information on student passage rates, curriculum, and instructors. A full-day site visit follows that includes meetings with administrators, the medical director, students, and instructors. Evaluators also visit clinical sites and examine all records kept by the school.

“Our first-time pass rate in the EMT Basic program is currently 96 percent and the national average pass rate is 72 percent,” WCCC Public Safety Services Coordinator Kim Fladung said. “We are very proud of our increase in first time pass rate over previous years and over the national average. That increase is a credit to the dedication of the instructors, the work of the students and the use of our new curriculum, which is a blended learning model of online and classroom instruction.”

Earlier in 2013, WCCC earned a three-year reaccreditation for its Fire Training programs.

WCCC Electricity Instructor Nominated as Life Changer

Warren County Career Center Electricity Instructor Rick Centers received notice recently that he was nominated as a Life Changer, a national award through National Life Group.

“Riding the Trail with Abraham Lincoln” by Gary Standafer

What are you thinking about when you bike the Little Miami trail? What daydreams are coming into your mind as you pedal the gentle curves and ever-so-slight inclines of the trail? As you look ahead, is it not easy to see a bend in the trail as a curve of railroad tracks bearing off ever so slightly to the right or to the left as the railroad follows the contour of the river? Now imagine a train with an engine and three coaches and let your imagination take you back in time to February 13, 1861. The train consists of a steam locomotive with coal hopper and three coaches carrying some very important passengers, one of whom will become the greatest president our nation may ever know. You are now sharing a ride with a man who will soon grow into near sainthood.

Your daydream has encompassed a small segment of President-Elect Lincoln’s 1,904-mile journey from Springfield, Illinois to his inauguration in Washington D.C. The journey began on February 11, 1861 when Abraham Lincoln departed his home in Springfield. He arrived in Cincinnati on the Wabash Line railroad on his 52nd birthday, February 12. At 8:30 the following morning, Lincoln, his wife Mary and their son Todd arrived at the Little Miami Railroad depot located near what we now know as Sawyer Point, near the end of Eggleston Avenue.

The train departed at 9:00 a.m. and traveled the entire distance of the Little Miami State Park before arriving in Xenia. The passengers in the three coaches consisted of journalists, local dignitaries, and the Lincoln family. **According to the New York Times, while the train stopped in Morrow, Mary Todd Lincoln was presented with a bouquet of flowers from the wife of the president of the Little Miami Railroad. Perhaps she was one of the dignitaries who rode this segment of Lincoln’s journey. The train traveled at 30 miles per hour and with short stops at Milford, Miami, Loveland, Morrow, and Corwin would have arrived shortly after noon that same day.** Coincidentally Corwin, Ohio is a small town on the river named after Thomas Corwin, a distinguished Warren County citizen and politician who would become a pall bearer at President Lincoln’s funeral in Washington D.C.

It is not likely that Lincoln made a speech at any of these stops, as none is recorded. It is likely, however, that he appeared on the rear platform of the train and he may have repeated a few simple words such as those he made at Xenia: “No speech to make, and no time to make one.” Or he may have said something similar to part of his Cincinnati speech, “I deem it my duty that I should wait until the last moment, for a development of the present national difficulties, before I express myself decidedly what course I shall pursue.” Or perhaps the few words he spoke a few days later in Painesville, Ohio, that ended in the phrase “I can only bid you good morning and farewell.”

As I ride my bicycle along the trail, I can’t help but look at the old telegraph poles, some still erect and some tumbling over, without thinking that these artifacts are the few remaining witnesses to the historic event I am sharing with this great president.

What to Know About Small-Business Licenses and Permits

So, you're starting a business – congratulations! You already know that there's a lot to take care of, from [choosing your business structure](#) to [registering your business](#). You'll probably also need a business license or permit – virtually every business does in order to operate legally. It depends on the kind of business you run, where it's located and what state and federal rules apply. Here's what you should know to make sure you'll be running your business within the law.

Why Does My Business Need a License or Permit?

[Licenses and permits](#)  serve two major purposes: They allow the government to track your business's revenue for tax purposes, and they also protect the public.

For example, if your business is involved in [activities supervised and regulated by a federal agency](#) – such as selling alcohol, firearms, radio broadcasting, commercial fishing, etc. – then you'll likely need to obtain a federal license or permit.

Other special state licenses, known as professional licenses, are required for dentists, hairdressers, veterinarians, realtors, physicians and more. These licenses indicate the level of expertise of an employee or business owner and that they've met a certain requirements when it comes to training or education. State licenses are also required of businesses, such as restaurants and those that serve alcohol, to demonstrate that they meet certain state standards or codes. Particular regulations may vary by state.


Defined by local and/or state laws, permits generally regulate the safety, structure and appearance of a community and its establishments. There are a number of different kinds of permits to be aware of, including:

- Seller's Permits – if you're purchasing wholesale merchandise for resale
- Building Permits – if you're remodeling or building commercial space
- Health Permits – if you're preparing food
- Home Occupation Permits – if you're running a home-based business

What About Tax Permits?

The IRS doesn't license your business, but it does require that certain businesses register to [receive a federal tax identification number](#). You'll also need to register with state and local government agencies for applicable tax permits such as a sales tax license, income tax withholding and unemployment insurance tax.

Managing and Maintaining Your License or Permit

[Once you have](#)  your license or permit, you'll need to manage and maintain it. Keep these tips in mind to help make sure you don't lose sight of your obligations:

- Keep track of renewal dates.
- Keep a copy of all licensing applications and forms in your business records.

- Display your licenses or permits correctly. Most states and localities require businesses to prominently display their business licenses so customers can see them.
- If you expand your business – whether it’s physical building expansion or launching a new product or service – you may need additional business licenses.

4 Marketing Resolutions to Make This Year

If there’s one area of operations most small businesses can stand to improve, it’s marketing. As a small business expert, I get more questions about marketing than any other aspect of business—and it’s been that way for the last 30 years. Since the New Year is all about improving oneself, how about making some marketing resolutions for your business? Here are four to consider.

1. I resolve to make a marketing plan. Many small business owners market haphazardly, throwing time and money at one marketing method and then, when it doesn’t pay off immediately, switching gears to the “next big thing.” This scattershot approach does nothing but waste your resources and leave you frustrated and frazzled, convinced that marketing doesn’t pay off. Instead, resolve to sit down and set goals for your marketing this year. What exactly do you want to accomplish—more leads, more sales closed, more inquiries? Once you’ve got goals on paper, figure out the marketing methods that are most likely to get those desired results. Finally, figure out how you’ll track results from each marketing method so you can see what’s really working.
2. I resolve to market consistently. It’s easy to fall into the trap of marketing only when you’ve got the “spare” time for it (which often means “never”). Or maybe you market wildly right before your busy season, then do nothing for months on end. As a result, your sales pipeline slows down. Keep your pipeline full by marketing consistently all year long. That doesn’t mean you need the *same* level of marketing year-round—for instance, a toy retailer would obviously market more before and during the holiday shopping season than in, say, July—but it does mean you need *some* level of marketing all year. Create a marketing calendar that sets out what you’ll do each month and breaks it down further into weekly and even daily marketing efforts. Then put someone in charge of making sure it’s all carried out.
3. I resolve to keep learning new things. Is your marketing stuck in the past? Advertising only in the print Yellow Pages might work if your clientele is solely seniors...and even seniors are increasingly going online to find businesses instead of letting their fingers do the walking. If you want your business to grow, you’ve got to keep up with the (marketing) times. Resolve to regularly read industry blogs and publications, attend networking events and conferences, and take webinars and seminars to learn more about new marketing trends and how they’re affecting your industry. Pledge to learn something new every month, and at least try some of it. Marketing is moving fast, and if you don’t keep up you’re going to get left behind.
4. I resolve to do market research. Many small business owners see market research as something they do once—when starting their companies—and then never do again. But what happens when your market changes? The 20-somethings you might have targeted with your extreme sports company in 1998 are now in their 40s. Even if they’re still buying extreme sports products, the way you market to them needs to be different now from what it was then. Keep tabs on the demographics of your target market

so you can adjust your marketing approach to changes in their incomes, lifestyles, media consumption habits and buying behaviors. Use both secondary research from other sources and primary research — that is, simply asking your customers what they want and need.

These four simple resolutions will make a big difference in your results.

SBA Announces New Measures to Help Get Small Business Loans into the Hands of Veterans

The U.S Small Business Administration (SBA) today announced new measures to help get small business loans into the hands of veterans by setting the borrower upfront fee to zero for all veteran loans authorized under the SBA Express program up to \$350,000. This initiative will start on January 1 and continue through the end of the fiscal year.

“Our nation’s veterans are highly-skilled and highly-trained leaders in their communities,” said Acting SBA Administrator Jeanne Hulit. “This initiative will set fees to zero for SBA Express loans to veterans up to \$350,000, and is part of SBA’s broader efforts to make sure that veterans have the tools they need to start and grow a business. As we honor our veterans and thank them for their service and sacrifice, let’s continue to identify ways to support them when they come home.”

Of all SBA loans that go to veterans, 73 percent are \$350,000 and below. The SBA Express Loan Program, which supports loans under \$350,000, is SBA’s most popular loan delivery method, with nearly 60 percent of all 7(a) loans over the past decade being authorized through the program. Since the program’s inception, it has also been one of the most popular delivery methods for getting capital into the hands of veteran borrowers. Building on SBA’s recent announcement that for the current fiscal year, fees on loans for \$150,000 and under are set to zero, this policy announcement means that veteran borrowers will no longer have to pay an upfront fee for any loan up to \$350,000 under the SBA Express program. This new initiative will go into effect January 1 and extend for the duration of the fiscal year. This will make the loans cheaper for the borrower, another way SBA is looking to serve small business owners as they look for ways to access capital.

Today’s announcement comes during SBA’s National Veterans Small Business Week, an initiative on the part of the U.S. Small Business Administration to reach out to veteran entrepreneurs and business owners. During Veterans Small Business Week, SBA staff all across the country have been working with partner organizations on educational efforts, mentoring, and trainings to make sure veterans have the tools they need to start or grow their business.

SBA provides veterans access to business counseling and training, capital and business development opportunities through government contracts. In FY 2013, SBA supported \$1.86 billion in loans for 3,094 veteran-owned small businesses. And since 2009, the dollar amount of SBA lending support to veteran-owned firms has nearly doubled.

If you are seeking health coverage through the Health Insurance Marketplace, be sure to [apply before the end of the open season on March 31, 2014](#). If you haven't enrolled by March 31, you won't be able to apply until the next open season, unless you qualify for a [special enrollment period](#) or experience a [qualifying life event](#). Open season for 2015 will likely begin on November 15, 2014. You can enroll in [Medicaid or the Children's Health Insurance Program \(CHIP\)](#) at any time. There is no limited enrollment period for these programs.

Top 10 Scams Targeting Seniors

Financial scams targeting seniors have become so prevalent that they're now considered "the crime of the 21st century." Why? Because seniors are thought to have a significant amount of money sitting in their accounts. Financial scams also often go unreported or can be difficult to prosecute, so they're considered a "low-risk" crime. However, they're devastating to many older adults and can leave them in a very vulnerable position with little time to recoup their losses. It's not just wealthy seniors who are targeted. Low-income older adults are also at risk of financial abuse. And it's not always strangers who perpetrate these crimes. Over 90% of all reported elder abuse is committed by an older person's own family members, most often their adult children, followed by grandchildren, nieces and nephews, and others. Review our list below, so you can identify a potential scam.

1. Health Care/Medicare/Health Insurance Fraud

Every U.S. citizen or permanent resident over age 65 qualifies for Medicare, so there is rarely any need for a scam artist to research what private health insurance company older people have in order to scam them out of some money. In these types of scams, perpetrators may pose as a Medicare representative to get older people to give them their personal information, or they will provide bogus services for elderly people at makeshift mobile clinics, then use the personal information they provide to bill Medicare and pocket the money.

2. Counterfeit Prescription Drugs

Most commonly, counterfeit drug scams operate on the Internet, where seniors increasingly go to find better prices on specialized medications. This scam is growing in popularity – since 2000, the FDA has investigated an average of 20 such cases per year, up from five a year in the 1990s. The danger is that besides paying money for something that will not help a person's medical condition, victims may purchase unsafe substances that can inflict even more harm. This scam can be as hard on the body as it is on the wallet.

3. Funeral & Cemetery Scams

The FBI warns about two types of funeral and cemetery fraud perpetrated on seniors. In one approach, scammers read obituaries and call or attend the funeral service of a complete stranger to take advantage of the grieving widow or widower. Claiming the deceased had an outstanding debt with them, scammers will try to extort money from relatives to settle the fake debts. Another tactic of disreputable funeral homes is to capitalize on family members' unfamiliarity with the considerable cost of funeral services to add unnecessary charges to the bill. In one common scam of this type, funeral directors will insist that a casket, usually one of the most expensive parts of funeral services, is necessary even when performing a direct cremation, which can be accomplished with a cardboard casket rather than an expensive display or burial casket.

4. Fraudulent Anti-Aging Products

In a society bombarded with images of the young and beautiful, it's not surprising that some older people feel the need to conceal their age in order to participate more fully in social circles and the workplace. After all, 60 is the new 40, right? It is in this spirit that many older Americans seek out new treatments and medications to maintain a youthful appearance, putting them at risk of scammers. Whether it's fake Botox like the one in Arizona that netted its distributors (who were convicted and jailed in 2006) \$1.5 million in barely a year, or completely bogus homeopathic remedies that do absolutely nothing, there is money in the anti-aging business. Botox scams are particularly unsettling, as renegade labs creating versions of the real thing may still be working with the root ingredient, botulism neurotoxin, which is one of the most toxic substances known to science. A bad batch can have health consequences far beyond wrinkles or drooping neck muscles.

5. Telemarketing

Perhaps the most common scheme is when scammers use fake telemarketing calls to prey on older people, who as a group make twice as many purchases over the phone than the national average. While the image of the lonely senior citizen with nobody to talk to may have something to do with this, it is far more likely that older people are more familiar with shopping over the phone, and therefore might not be fully aware of the risk. With no face-to-face interaction, and no paper trail, these scams are incredibly hard to trace. Also, once a successful deal has been made, the buyer's name is then shared with similar schemers looking for easy targets, sometimes defrauding the same person repeatedly. Examples of telemarketing fraud include:

"The Pigeon Drop"

The con artist tells the individual that he/she has found a large sum of money and is willing to split it if the person will make a "good faith" payment by withdrawing funds from his/her bank account. Often, a second con artist is involved, posing as a lawyer, banker, or some other trustworthy stranger.

"The Fake Accident Ploy"

The con artist gets the victim to wire or send money on the pretext that the person's child or another relative is in the hospital and needs the money.

"Charity Scams"

Money is solicited for fake charities. This often occurs after natural disasters.

6. Internet Fraud

While using the Internet is a great skill at any age, the slower speed of adoption among some older people makes them easier targets for automated Internet scams that are ubiquitous on the web and email programs. Pop-up browser windows simulating virus-scanning software will fool victims into either downloading a fake anti-virus program (at a substantial cost) or an actual virus that will open up whatever information is on the user's computer to scammers. Their unfamiliarity with the less visible aspects of browsing the web (firewalls and built-in virus protection, for example) make seniors especially susceptible to such traps. One example includes:

"Email/Phishing Scams"

A senior receives email messages that appear to be from a legitimate company or institution, asking them to "update" or "verify" their personal information. A senior receives emails that appear to be from the IRS about a tax refund.

7. Investment Schemes

Because many seniors find themselves planning for retirement and managing their savings once they finish working, a number of investment schemes have been targeted at seniors looking to safeguard their cash for their later years. From pyramid schemes like Bernie Madoff's (which counted a number of senior citizens among its victims) to fables of a Nigerian prince looking for a partner to claim inheritance money to complex financial products that many economists don't even understand, investment schemes have long been a successful way to take advantage of older people.

8. Homeowner/Reverse Mortgage Scams

Scammers like to take advantage of the fact that many people above a certain age own their homes, a valuable asset that increases the potential dollar value of a certain scam. A particularly elaborate property tax scam in San Diego saw fraudsters sending personalized letters to different properties apparently on behalf of the

County Assessor's Office. The letter, made to look official but displaying only public information, would identify the property's assessed value and offer the homeowner, for a fee of course, to arrange for a reassessment of the property's value and therefore the tax burden associated with it. Closely related, the reverse mortgage scam has mushroomed in recent years. With legitimate reverse mortgages increasing in frequency more than 1,300% between 1999 and 2008, scammers are taking advantage of this new popularity. As opposed to official refinancing schemes, however, unsecured reverse mortgages can lead property owners to lose their homes when the perpetrators offer money or a free house somewhere else in exchange for the title to the property.

9. Sweepstakes & Lottery Scams

This simple scam is one that many are familiar with, and it capitalizes on the notion that "there's no such thing as a free lunch." Here, scammers inform their mark that they have won a lottery or sweepstakes of some kind and need to make some sort of payment to unlock the supposed prize. Often, seniors will be sent a check that they can deposit in their bank account, knowing that while it shows up in their account immediately, it will take a few days before the (fake) check is rejected. During that time, the criminals will quickly collect money for supposed fees or taxes on the prize, which they pocket while the victim has the "prize money" removed from his or her account as soon as the check bounces.

10. The Grandparent Scam

The Grandparent Scam is so simple and so devious because it uses one of older adults' most reliable assets, their hearts. Scammers will place a call to an older person and when the mark picks up, they will say something along the lines of: "Hi Grandma, do you know who this is?" When the unsuspecting grandparent guesses the name of the grandchild the scammer most sounds like, the scammer has established a fake identity without having done a lick of background research. Once "in," the fake grandchild will usually ask for money to solve some unexpected financial problem (overdue rent, payment for car repairs, etc.), to be paid via Western Union or MoneyGram, which don't always require identification to collect. At the same time, the scam artist will beg the grandparent "please don't tell my parents, they would kill me." While the sums from such a scam are likely to be in the hundreds, the very fact that no research is needed makes this a scam that can be perpetrated over and over at very little cost to the scammer.

The holidays have come and gone. Most of the country has already been in a deep freeze, and there are still long, harsh months of winter yet to come. It's no wonder many people come down with a case of the "winter blues." This bummed out reaction occurs when the days are shorter and you spend much more time inside. To combat these feelings, you might try [light therapy](#), and [increasing physical activity](#). If it lasts more than a fleeting day or two, it could be [seasonal affective disorder](#) (SAD) -- a serious form of [depression](#) occurring in the winter months when there is less exposure to natural sunlight. Some symptoms of SAD include:

- Feelings of worthlessness or helplessness
- Loss of interest or pleasure in activities you used to enjoy
- Fatigue or decreased energy

If you suspect your mental state is more than just a bad day, consider these ways to get help:

- The Substance Abuse & Mental Health Services Administration ([SAMHSA](#)) has a 24-hour helpline (1-800-662-HELP) for mental health services if you or someone you know needs immediate attention.
- [Find a doctor](#). SAD is not something you should deal with without consulting a professional. After evaluation, they may be able to prescribe a [medication](#) to help you.

Avoid Tax-Related Identity Theft

Imagine filing your taxes only to learn that someone stole your identity, filed your tax return, and received a refund in your name. Unfortunately, this scenario may be a reality for many consumers this tax season.

According to the Federal Trade Commission, 43 percent of identity theft complaints nationwide are tax-related. To fight back against fraud, the Federal Trade Commission has designated the week of Jan. 13–17 as National Tax Identity Theft Awareness Week.

Reports to the Attorney General's Office suggest that Ohioans continue to be affected by tax-related identity theft. A Trumbull County consumer attempted to file taxes online, only to find that someone had obtained his Social Security number and received a tax refund from the IRS in his name. A Lorain County consumer reported a similar situation and stated the IRS could not process her \$3,500 refund since the refund was already issued.

You can protect yourself from tax-related identity theft in a number of ways. If you plan to use a tax preparation service, research the reputation of the business by contacting the Ohio Attorney General and the Better Business Bureau. In some cases, fraudsters pose as legitimate tax preparers in order to obtain your personal information — and possibly your refund. They may use your personal information to route your refund into their personal bank account. Beware of “tax preparers” who suggest issuing your refund on a prepaid credit card. Once your refund is loaded on the card, the “preparer” could use the card number to steal your refund.

You can also reduce your risk of tax-related identity theft by filing your taxes early. Each day you wait to file your taxes, is one day more that someone has to perpetrate identity theft. Employers are required to provide you with your W-2 by Jan. 31, 2014. Be sure to keep track of your mail around the time that W-2 forms are distributed to ensure that your W-2 (or any other tax-related document) has not been taken out of your mailbox. You may want to have your W-2 provided to you electronically if your employer allows that option.

In addition to protecting your identity, avoid offers for fast-cash refunds or instant refunds. An “instant refund” may be a costly loan based on your expected tax return. It also could be a refund anticipation check—a temporary account in which your refund will be deposited and from which preparation fees and other costs will be deducted. Although refund anticipation loans or checks may allow you to receive your refund money a few days early, they may not be worth the high cost.

The Ohio Attorney General's Office has also taken complaints about scammers claiming a consumer owes taxes. They may pose as an IRS representative, an “officer,” or other official-sounding professional in an attempt to receive payment from unsuspecting consumers.

2014 IRS Due Dates

Get Ready For The Tax Filing Season

This week we will look at some of the more common forms that you should be watching for in the coming weeks and months:

W-2: Employers should mail these **by 1/31/14**. If you have moved during the year, make sure former employers are aware of your new address.

W-2G: Casinos, Lottery Commissions and other gambling entities should mail these **by 1/31/14** if you have gambling winnings above a certain threshold.

NOTE: Some casinos will issue you a W-2G at the time you win a jackpot. Make sure you have saved those throughout the year.

1099-INT: Banks, Credit Unions, Brokerage firms, etc. will issue these **by 1/31/14** to show the amount of interest income you earned on your savings/investments.

1099-DIV: Brokerage firms, mutual funds, etc. have **until 2/14/14** to issue these forms to show the dividend income you earned for the year.

1099-B: Brokerage firms, mutual funds, etc. have **until 2/14/14** to show the proceeds from the sale of stocks

and mutual funds. Most brokerage firms have gotten better at showing the cost basis on the sale of these investments. If the statements do not show the basis, then you have some homework to do before filing your tax return.

NOTE: Most of the larger brokerage firms issue "Consolidated Statements" that have the 1099-INT, 1099-DIV and 1099-B earnings reported on the same report.

K-1s: If you are a partner in a business or a limited partner in some investments, your income and expenses will be reported to you on a K-1. The tax returns for these entities are not due **until 4/15/14** (if they have a calendar-year accounting). Sometimes, you may not receive a K-1 until shortly after the entities' tax return is filed in April.

If you are a beneficiary of an estate or trust, your share of the income and expenses for the year will also be reported on a K-1. The timing of when you may receive your K-1 is the same as outlined above.

NOTE: Many times partnerships, estates and trusts will put their tax returns on extension. If they do, the due date of the return is not **until 9/15/14**. We often see client's receiving K-1s in the third week of September.

If you receive, or expect to receive, a K-1 it may be best if you place your personal return on extension. It is a lot easier to extend your return than it is to amend your return after receiving a K-1 late in the year. So start watching your mailbox and put all of these statements you receive in that new file you created!

Test Your Home for Radon

Where Can I Get a Radon Test Kit?

If you are interested in finding a qualified radon service professional to test your home, you wish to purchase a radon test kit, or have questions about a radon measurement device: Contact your State Radon Contact to determine what are, or whether there are, requirements associated with providing radon measurement and or radon mitigations/reductions in your State. Some States maintain lists of contractors available in their state or

they have proficiency programs or requirements of their own. Some states offer free or discounted test kits to the public. The National Radon Program Services at Kansas State University offers discounted test kits available to purchase online.
