Call to Order

The Regular Session of Council was called to order by Mayor York Bryant. The meeting was opened with the Pledge of Allegiance.

Approval of Minutes of Previous Meeting

Jones Warner Engineering

Phil Kaufman, Village of Morrow Water Operator, gave an update from Shawn Campbell regarding the engineering issues. The booster station is at OPWC and should be ready to bid out next month. New section in the Woodlands of Morrow, 4D, storm water and water lines should be finished next week. The Mayor stated there needs to be a new cover put over a drain on Welch Road. Discussion followed.

Reports / Legislation from Village Officials

Monthly Village Fiscal Revenue Status by Fund Summary, Bank Reconciliation and Disbursements, Mayor's Court Report and Bank Reconciliation were provided for Council.

The Mayor was pleased with the turn out for the 4th of July parade organized by Bryson's Automotive. The parade was a great success for the village. The mayor also discussed the auction of the generator, lawn mower, borer with pipes and wood chipper. Details of the closed bid sale were given and there was concern expressed about the procedures used in conducting the auction. Discussion followed. The Solicitor was asked to produce an ordinance regarding future sales. The mayor praised the maintenance and summer crew for keeping the Village looking great.

Public Forum

Mr. Herb Erwin and Solicitor Kaspar discussed a proposed resolution needing Council's up or down vote for the agreement of the discussed conditions for the sale of 323 Main Street. Solicitor called for a vote; Council approved.

Isaac Shelton introduced himself to Council and asked where he should start on using part of the depot for a bicycle shop. Mr. Shelton was referred to the Village Administrator to move forward.
